The Fair Wear Foundation (FWF) is an international non-profit working to improve labor conditions in the global garment industry. Focused on fair wages, safe workplaces, and workers' rights in factories, FWF partners with brands to conduct independent audits, offer worker training, and run complaint mechanisms—mainly in countries like Bangladesh, Vietnam, and China.



Better Cotton is the world's largest sustainable cotton initiative, covering over 20% of global production. It trains 2.13 million farmers in 22 countries on eco-friendly and socially responsible practices—like reducing pesticide use, conserving water, and ensuring fair labor. Licensed farmers meet field-level standards, verified by independent certification bodies.



The **OEKO-TEX® Standard 100** is a globally recognized label that certifies textiles tested for over 1,000 harmful substances. Covering all product components, it ensures consumer safety—especially in Class I, the strictest level for baby items. Widely used, especially in Europe, it promotes safe, responsible textile production.



Cradle to Cradle Certified® is a global standard for sustainable, circular products designed to be safely reused or recycled. Managed by a U.S. nonprofit, it evaluates material health, circularity, climate impact, water and soil use, and social fairness.



GOTS (Global Organic Textile Standard) is a leading certification for textiles made from organic natural fibers like cotton and wool. It ensures eco-friendly processing and fair labor from farm to finished product, banning hazardous chemicals and enforcing ILO standards. Widely used in Europe, the U.S., and Japan.



The Responsible Wool Standard (RWS) certifies wool from farms that practice high animal welfare and land management standards. It ensures ethical treatment of sheep and sustainable farming, promoting transparency and traceability in the wool supply chain.



The Global Recycled Standard (GRS) certifies products with at least 50% recycled content made in an environmentally and socially responsible way.

It ensures traceability throughout the supply chain, bans hazardous chemicals, promotes waste management, and protects workers' rights.

GRS aims to reduce environmental impact and boost transparency in sustainable fashion.



IVN BEST is Europe's strictest ecological textile standard, ensuring products are 100% natural and sourced from certified organic fibers. It limits synthetic fibers to 5% and bans harmful practices like artificial cotton removal. Companies must follow environmental policies covering pollution control, energy and water use, and chemical safety to promote sustainable production.



SA8000

SA8000 is a global certification for social responsibility, ensuring ethical working conditions across supply chains. Based on ILO and UN standards, it covers issues like forced labor, child labor, safety, fair wages, and non-discrimination. Common in industries like textiles, electronics, and food, it helps companies prove their commitment to human rights and ethical practices.

OEKO-TEX®

ECO PASSPORT

OEKO-TEX® ECO PASSPORT certifies chemicals, dyes, and auxiliaries used in textiles and leather, ensuring they are safe for people and the environment. It includes ingredient checks, lab testing, and compliance with regulations like REACH and ZDHC. Widely used in Europe, North America, and Asia to support safer, more sustainable production.

OEKO-TEX®

STeP

OEKO-TEX® STeP (Sustainable Textile & Leather Production) is a global certification for environmentally friendly and socially responsible manufacturing. It evaluates production facilities on sustainability, chemical management, environmental impact, occupational safety, and social responsibility—promoting transparency and continuous improvement across the supply chain.



Fairtrade Cotton certifies that cotton is sourced from farms with fair wages, safe conditions, and sustainable practices. Focused on ethical trade and environmental standards, it's most common in Africa, India, and Latin America.



Zero Discharge of
Hazardous Chemicals

ZDHC (Zero Discharge of Hazardous Chemicals) is a standard for the textile, clothing, and footwear industries, aimed at eliminating harmful chemicals from production. It promotes safer conditions for workers, consumers, and the environment through better material choices, waste management, and improved workplace practices. Widely adopted in Asia, it's growing in Europe and the U.S.



The **Recycled Claim Standard** (RCS) verifies the presence and amount of recycled materials in a final product. It ensures traceability through the supply chain via third-party certification. Used in fashion, textiles, and packaging, RCS supports transparency and promotes responsible use of recycled content.



bluesign® is a certification for sustainable textile production, ensuring that products are made with safe chemicals, minimal environmental impact, and responsible resource use. It covers the entire supply chain, protecting workers, consumers, and the planet.



The **EU Ecolabel** is an official European certification for products and services with high environmental standards throughout their lifecycle. It promotes eco-friendly choices by ensuring reduced impact on the environment, covering everything from production to disposal.

A closer look at current and upcoming regulations

Major regulatory changes are reshaping the textile and apparel industry.

From stricter chemical bans to mandatory transparency tools, the years ahead will demand increased accountability and sustainability.

Timeline:

2025: Finalization of regulations

2026 - 2029: Gradual enforcement and rollout

EU Green Deal

A long-term strategy to make Europe climate neutral by 2050, it promotes circular economy practices and sustainable production

Green Claims Directive

To protect consumers and ensure trust, all environmental marketing claims must be supported by verifiable data, using standard methods and clear language.

ESPR and DPP

The Ecodesign for Sustainable Products Regulation (ESPR) sets new rules for textiles to be durable, repairable, and recyclable. The Digital Product Passport (DPP) will provide key product data to support transparency and circular use.

Corporate Sustainability Due Diligence Directive (CSDDD)

Large companies will be legally required to assess and manage social and environmental risks across their supply chains, from raw materials to finished products.

PFAS and REACH

The EU is moving to phase out PFAS, known as "forever chemicals," due to their health and environmental impact. Other harmful substances are also under stricter control via REACH.

Textile Labelling and Extended Producer Responsibility (EPR)

New rules on fiber content labels and producer responsibility mean brands will handle the costs and logistics of textile waste collection, sorting, and recycling.
